The Royal Astronomical Society

- 'Learned Society': began life as Astronomical Society of London in 1820; received royal charter in 1831
- "…encourages and promotes the study of astronomy, solar-system science, geophysics and closely related branches of science."
- William Herschel was first president; current incumbent is Prof Martin Barstow (until 2016)

- Major investment of £1 million from RAS reserves for outreach and engagement projects
- Grass roots projects that extend reach and appeal of Society into new areas of society
- Legacy of embedding astronomy and geophysics that will ensure our sciences retain their appeal
- Inspire young and old alike
- Set the RAS on course for the next 200 years as an outward looking society

- 9 May 2014: Official launch of Astonishing Astronomy and Glorious Geophysics
- 24 May 2014: Name change to 'RAS 200: Sky & Earth'
- May July 2014: Consultation of astronomy and geophysics communities
- 16 July 2014: (National) stakeholder meeting
- Autumn 2014: 'Town hall' meetings in key locations

RAS 200: Timetable (future)

- 1 December 2014: Applications open for outline proposal
- 2 February 2015: Deadline for outline proposals
- 2 March 2015: Maximum of 12 consortia invited to submit full bids for grants
- 10 April 2015: Deadline for full proposals
- 8 May 2015: Up to 6 'Winners' announced at RAS AGM (first tranche)

- Long term legacy and high potential for mainstreaming
- Engagement with diverse audiences
- Partnership with organisations 'new' to RAS
