# MINUTES OF THE COUNCIL MEETING <br> HELD DURING <br> THE NATIONAL ASTRONOMY MEETING <br> ST ANDREWS <br> 5 JULY 2013 

## 1. INTRODUCTION

## 2. MINUTES

The Minutes of the meeting of $10^{\text {th }}$ May 2013 were approved.

## 3. PRESIDENT'S BUSINESS

The President advised that as this was a short Council meeting, in the interests of time, this item would be passed over and that he would make a full report in October.

## 4. TREASURER'S BUSINESS

The Treasurer advised that he had received the updated valuation of the staff pension schemes from the actuary. Council will be asked to discuss the issues arising at the Council meeting in October.

## 5. ORGANISATION AND STRUCTURE

5.1 Review of NAM 2013

The President introduced this item by formally recording the Society's thanks to Professor Alan Hood and his team for arranging a successful and enjoyable NAM. Council discussed in some detail the arrangements for the RAS Community Session, including the RAS Awards session, and agreed that the points set out below should be incorporated into arrangements for future NAMs.

## Lunchtime events

- Important to ensure there is effective liaison and agreement between RAS and the Local Organising Committee (LOC) on arrangements for the Careers \& Women's lunches.
- It was noted that the Women's lunch should in future be renamed the Equality \& Diversity Lunch.


## RAS Community Session

- Judging by attendance and reaction, the RAS has been lax in not explaining to NAM attendees what constitutes the RAS Community Session, (in 2013 this included a presentation from STFC, a presentation from UKSA and the RAS Awards Ceremony.)
- The content of this session should be actively promoted including in advance in the NAM programme. In particular the Awards Ceremony needs to be promoted to encourage a better attendance (see separate note below)
- Conference attendees should be encouraged/challenged to come along, e.g. ' your chance to directly engage with the Research Council' e.g. 'Come and ask the Research Council why there is no more money? Ask them what they are doing about it. ${ }^{\prime}$
- Consideration should be given to an alternative format for this session. Options include establishing a post doctorate select committee to ask questions of the funding bodies.
- It was noted that NERC as well as STFC could be asked to be present.
- Essential to encourage younger conference attendees to come along and so to ensure some aspect of the session is geared towards more junior fellows. In any case, LOC should arrange for an email to be sent to all the students that register telling them what happens at the community session and encouraging them to come along.


## Awards Ceremony

- It was agreed that this should be advertised in the NAM programme. LOC should arrange a photographer for the event, who should take additional pictures after the ceremony to show medals received (as medals are boxed so not visible on handover.]
- It was noted that pictures of the medals could be shown on the background screen whilst award being given.
- Awardees should be briefed in advance on what is expected of them on the day.
- The RAS Awards Committee is to agree a standard format for the citations (a couple of paragraphs, maximum $1 / 2$ page) and to draft short citations for each award. (It was noted that this should include as the final line 'For these reasons [INSERT NAME] is awarded the [INSERT NAME] medal.'
- The LOC should source university students to read out the citations at the awards ceremony.


## Liaison with MIST/SOLAR groups

- Essential to ensure that Scientific Organising Committee (SOC) engage with MIST and Solar communities whilst planning programme.


## Public lectures

- Essential to ensure that public lectures are well advertised and that local schools and astronomy organisations are encouraged to attend.
- It was proposed that it may be better to arrange the public lectures on non-consecutive days.


## Lecture facilities

- Essential to ensure that blackout facilities are available in all lecture rooms.


## Scientific programme

- On a reciprocal basis, the Society hopes to be able to invite the equivalent of the Gold Medal winner from the American Astronomical Society (AAS) to give a talk at NAM. SOC should schedule a prominent session. AAS are to confirm whether this is possible for NAM 2014.
- Suggestion of not holding a plenary session the morning after the social event.


## Accommodation

- It was noted that finding accommodation had been challenging in St. Andrews (although this had been acknowledged and made clear to all very early on) and that some of the student accommodation was a distance from the conference facilities.
- LOC should consider arrange a shuttle bus between accommodation and conference facilities, if accommodation is as distant in future NAM's as at St Andrews.


## Poster session

- Essential that posters on display for whole period of conference, as was done at St Andrews.
- RAS to agree who will judge posters at the May Council mtg.
- Timing and arrangements for the presentation of best poster prizes to be agreed in advance and advertised in programme.

Give the student a voice (people's choice award)

- Consideration should be given to developing a system that allows NAM student attendees to elect a "best plenary speaker".


### 5.2 Record of decisions taken at the RAS Strategic Planning Meeting

Council agreed that the Treasurer and Executive should work with the necessary RAS Committees and Subject Matter Experts over the summer to present a costed options paper to Council for approval in October 2013.

## 6. POLICY AND PUBLIC ENGAGEMENT

6.1 House of Lords Science and Technology Committee inquiry into Scientific infrastructure: Response from the RAS (Deputy Exec. Sec)

6.2 House of Commons Business, Innovation and Skills Select Committee: inquiry into the implications of Scottish independence (Deputy Exec. Sec.)

6.3 Science and Technology Select Committee: inquiry into Women in STEM careers (Deputy Exec. Sec.)

The House of Commons Science and Technology Select Committee have launched an inquiry into women in Science, Technology, Engineering and Mathematics (STEM) careers in both industry and academia. MPs are particularly interested in the 'leaky pipeline', whereby the proportion of women in these occupations declines with age and seniority.

The deadline for submissions is $3^{\text {rd }}$ September 2013.

Council were reminded that the Department for Business, Innovation and Skills are seeking evidence in support of a review of the balance of powers between the UK and EU in the fields of research, development, technology and space. The deadline for evidence submission is Tuesday $6^{\text {th }}$ August 2013.

### 7.1 Membership of the GJI Editorial Board

Council noted the following changes to the membership of the GJI Editorial Board:

- Dr Oliver Ritter will step down from the Editorial Board of GJI after 7 years.
- Two new editors have agreed to join the Board:
- Dr Ute Weckmann, from the GeoForschungsZentrum Potsdam will replace Oliver Ritter, covering all aspects of EM methodology.
- Prof. Sang-Heon Shim (Dan) from Arizona State University. His interest areas are Mineral Physics and Earth and planetary interiors.
